#### Statement of Case - Reference 4.6

That the Council strongly feels that the reference quoted from the Central West Somerset Character Area (WSLCA 1999) of "buildings are mostly small, two storey cottages of simple form" is misleading and this "blanket description" does not appropriately describe the area in which the application site is located. The significant characteristics of the properties in this section of Tower Hill is that of larger detached or semi-detached housing in large plots.

#### **Resolution 5**

### Statement of Case - Reference 4.7 and Figure 1

That the Council strongly feels this is misleading and not a true reflection of the locality surrounding the application. The area shown in Figure 1 is a significant distance from the site and is not representative of Tower Hill as evidenced by Figure 3, Aerial photograph.

#### **Resolution 6**

#### Statement of Case - Reference 5.3

That the Council feels that the reference to Taunton Deane's five-year land supply is irrelevant as this application is within West Somerset. This is confirmed within the written statement from the Local Planning Authority which also provides more up to date data regarding the 5-year housing supply.
